8. Selected PLV shall be required to undergo training programme as per decision of the District Legal Services Authority, Biswanath.
9. In case of any objection regarding selection of PLVs, the decision of the Chairman, District Legal Services Authority, Biswanath shall be final and binding on all concerned.
