**GENERAL TERMS & CONDITIONS**

1. The sealed envelope containing quotation shall be marked as "Quotation for Supply of Sofa Set for Office of District & Sessions Judge, Sonitpur, Tezpur" and the following documents must be annexed with the quotation.
  - a) Copy of PAN Card.
  - b) Up-to-date GST Registration Certificate.

Each page of the aforementioned documents should be signed by the bidder to establish the Bidder's eligibility and its qualification to perform the supply of materials if its bid is accepted. In the absence of any of the above documents / information, the offer may be summarily rejected without making any further reference in this regard.

The sealed quotation should be submitted to the office of **the District and Sessions Judge, Sonitpur, Tezpur**, during office hours on working days.

2. The rate approved by the Purchase Committee constituted for the selection of bidder, shall be valid for the said item. Increase and decrease of Prices, Taxes and other statutory duties will not affect the price during this period of supply. The supplier will be responsible for any increase in Prices, Taxes and Duties. Any increase in taxes and other statutory duties/levies after the approval of Rates shall be to the supplier's account. The bidder shall provide **free delivery and free installation** of the item in the Officers quarter.
3. Payments shall be made after satisfactory execution of the order and supply of item in satisfactory condition on bill basis. The decision of the District and Sessions Judge, Sonitpur, Tezpur, towards satisfaction of quality of material shall be final. Payment of the item supplied under purchase order will be paid on receipt of complete consignment and checking of the material and on production of bills in triplicate.

4. The District and Sessions Judge, Sonitpur, Tezpur, reserves the right to accept or reject any or all the tenders in part or full, without assigning any reason whatsoever.
5. The District and Sessions Judge, Sonitpur, Tezpur, is not bound to accept the lowest Tender.
6. The District and Sessions Judge, Sonitpur, Tezpur, reserves the right, to award the work to one or more bidders. No communication shall be made in this regard except the selected firm/tenderer/bidder.
7. The District and Sessions Judge, Sonitpur, Tezpur, reserves the right to terminate the order at any time by giving intimation in writing without assigning any reason.
8. In case of violation of terms and conditions of the tender document or unsatisfactory supply of material or of poor quality and below standard. The District and Sessions Judge, Sonitpur, Tezpur, reserves the right to terminate the supply order by giving intimation to the supplier.

The sealed quotations should reach the undersigned on or before **20-01-2020 (Monday)** & no quotation/tender will be received thereafter. The tenders shall be opened in the office of the District and Sessions Judge, Sonitpur, Tezpur, on **21-01-2020 (Tuesday)** at **4.30 PM**.

9. **The decision of the District and Sessions Judge, Sonitpur, Tezpur, in all respect shall be final and binding on all.**

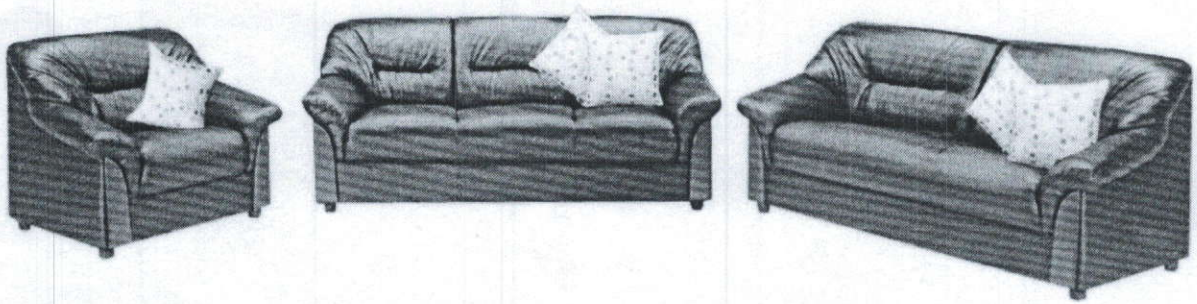

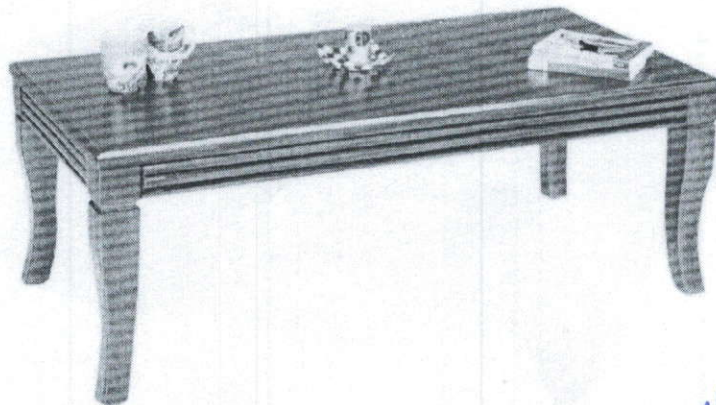
