GENERAL TERMS & CONDITIONS

1. The sealed envelope containing quotation should be marked as "**Quotation for installation of Optical Fiber Connectivity (OFC)**" and the following documents must be annexed with the quotation.

- a) Copy of **PAN** Card.
- b) Up to date copy of **VAT** Registration certificate.
- c) Up to date copy of **VAT** Clearance certificate.

Each page of the aforementioned documents should be signed by the bidder with seal to establish the Bidder's eligibility and its qualification to perform the supply of materials if its bid is accepted. In the absence of any of the above documents / information, the offer may be summarily rejected without making any further reference in this regard.

The sealed quotation should be submitted to the office of **the District and Sessions Judge, Sonitpur, Tezpur**, during office hours on working days.

2. The rates approved by the ICT Committee, shall be valid for the said item/items. Increase and decrease of Prices, Taxes and other statutory duties will not affect the price during this period of supply. The supplier will be responsible for any increase in Prices, Taxes and Duties. Any increase in taxes and other statutory duties/levies after the approval of Rates shall be to the supplier's account. The bidder shall provide free delivery, free installation and operation training to the authorized personnel of the office.

3. Payments shall be made after satisfactory execution of the work, on production of following:

- Invoice in triplicate,
- Delivery Challan duly signed by the consignee.

4. The District and Sessions Judge, Sonitpur, Tezpur, reserves the right to accept or reject any or all the tenders in part or full, without assigning any reason whatsoever.

5. The District and Sessions Judge, Sonitpur, Tezpur, is not bound to accept the lowest Tender.

6. The District and Sessions Judge, Sonitpur, Tezpur, reserves the right, to award the work to one or more bidders. No communication shall be made in this regard except the selected firm/tenderer/bidder.

7. The District and Sessions Judge, Sonitpur, Tezpur, reserves the right to terminate the purchase order at any time by giving intimation in writing without assigning any reason.

8. In case of violation of terms and conditions of the tender document or unsatisfactory supply of material or of poor quality and below standard. The District and Sessions Judge, Sonitpur, Tezpur, reserves the right to terminate the supply order by giving intimation to the supplier.


9. Before submitting the quotation, interested party may inspect the proposed area of the work, so as to avoid any inconvenience after finalization of work.
