GENERAL TERMS AND CONDITIONS

1. The sealed envelope containing quotation shall be marked as “**Quotation for hiring a LMV**” on monthly rental basis for use of the Chief Judicial Magistrate, Sonitpur, Tezpur. and the following documents must be annexed with the quotation.

- a) Copy of PAN Card
- b) Copy of GST Registration Certificate
- c) Copy of valid documents, Vehicle Registration Certificate, Vehicle Insurance Policy, Vehicle Pollution Certificate.

2. In the absence of any of the above documents/ information, the quotation may be summarily rejected without making any further reference in this regard.

The sealed quotation should be submitted to the Office of **the Chief Judicial Magistrate, Sonitpur, Tezpur** during office hours on working days.

3. The Bidders should quote specific rates as per specific vehicles as per requirement. The rate of the vehicles and the GST should be shown separately. The rates quoted by the bidders shall be as per the Government Transport Department's approved rates. The price quoted by the bidders shall remain fixed during the entire period of contract as per the agreement.

4. The rates approved by the committee constituted for the selection of bidder, shall be valid for the period of one year from the date of actual hiring.

5. Payments on hiring of vehicle shall be made on monthly basis as and when budget received from the Hon'ble Gauhati High Court.
6. The fuel will be provided by the office of the Chief Judicial Magistrate, Sonitpur, Tezpur.
7. The entire general maintenance of the vehicle shall be borne by the bidder. Office will provide the fuel corresponding to its use.
8. The contract may be terminated by a notice of one month from either side.

9. The undersigned reserves the right to accept or reject any tender, without assigning any reason whatsoever.

10. The undersigned is not bound to accept the lowest tender.

11. The undersigned reserves the right to terminate the agreement at any time by giving intimation in writing without assigning any reason.
