1. The sealed envelope containing quotation shall be marked as “**Quotation for Supply of Water Purifier**” and the following documents must be annexed with the quotation.
 - a) Copy of PAN Card
 - b) Copy of GST Registration Certificate
 - c) Copy of Tezpur Municipal Board Trade License.

Each page of the documents should be signed by the bidder with seal to establish the Bidder's eligibility and its qualification to perform the supply of materials if its bid is accepted. In the absence of any of the above documents/ information, the offer may be summarily rejected without making any further reference in this regard.

The sealed quotation should be submitted to the Office of **the Chief Judicial Magistrate, Sonitpur, Tezpur** during office hours on working days.

2. Payments shall be made after satisfactory execution of the order and supply of material in satisfactory condition on bill basis. The decision of the Hon'ble Chief Judicial Magistrate, Sonitpur, Tezpur towards satisfaction of quality of material shall be final. Payment of the material supplied under purchase order will be paid on receipt of complete consignment and checking of the material and on production of following :

- Invoice in triplicate
- Delivery Challan duly signed by the consignee.
