**O R D E R**

In the light of the recommendation of Selection Board, it is hereby notified to all the eligible candidates applied for the post of 05 (Five) numbers Attached Peon, 01 (One) number of Court Attached peon and 01 (One) number of Office Peon in the establishment of Chief Judicial Magistrate, Tezpur, Sonitpur and SDJM(M), Gohpur that the Govt. of Assam vide its Order dated 02.08.2020 No. ASDMA-24/20/Part-1/96 permitted "Inter District Movement" on Monday and Tuesday only. Hence, it is notified to all the candidates who applied for the aforesaid post from the outside district their oral Interview/ Viva-Voce examination is going to be held on 10.08.2020 and 11.08.2020 from 9 AM onwards.

Further, the Oral interview/ Viva-Voce examination of the remaining candidates is going to be held on other official notified working days as per the schedule mentioned herein after. It is further notified to all the eligible candidates that during the time of interview strict compliance of "Social Distancing" is necessary and they shall comply the followings:-

- i) Every candidates shall wear mask during the time of interview,
- ii) They shall bring the original testimonials,
- iii) They shall enter the precinct of establishment of Chief Judicial Magistrate, Sonitpur at Tezpur after proper sanitization in the main gate and stand in the queue mark fixed by the selection board,
- iv) They shall use the hand sanitizer meant for them outside the precinct of the court premises,
- v) They shall keep distancing at least 6 feet to 10 feet from each other,

- vi) They shall enter the precinct of Chief Judicial Magistrate, Sonitpur at Tezpur as per the time slot provided in the schedule of interview,
- vii) Unnecessary gathering of the candidates beyond the permissible limit of time slot shall be taken seriously which may go up to the cancelation of their candidature,
- viii) For example, if a candidate is asked to remain present from 10 AM to 11 AM, he has to appear as per the time slot and enter through the main gate after proper sanitization and appear before the Oral Interview/ Viva-Voce examination before the selection board,
- ix) In the event, a candidate fails to attend Oral Interview/ Viva-Voce examination as per the time slot his interview will be conducted as per the norms fixed by the selection board in following date.
- x) Canvassing through any means regarding the interview shall be taken seriously by the selection board.

Accordingly, following schedule of interview with time slots is notified for holding the "Oral Interview/ Viva-Voce examination" of the eligible candidates which already notified vide its official order Memo No.CJM(S) 1353 dated 29.07.2020.
